Where the tax-free threshold is claimed and your employee earns:

- more than \$3,275 but less than \$3,461, withhold \$1,040 plus 39.00 cents for each \$1 of earnings in excess of \$3,275
- more than \$3,460, withhold \$1,113 plus 47.00 cents for each \$1 of earnings in excess of \$3,460.

Where the tax-free threshold is not claimed and your employee earns more than \$3,275, withhold \$1,190 plus 47.00 cents for each \$1 of earnings in excess of \$3,275.

For all withholding amounts calculated, round the result to the nearest dollar.
